Lincoln College Schedule of Fees Information

(All costs are in Australian dollars)

- Residence of Lincoln College is normally for the full academic year.
- Residents wishing to terminate their residency before the end of their contract should note that they remain liable for their fees until the end of their contract.
- No refunds will apply to residents leaving before the end of their contract date.
- All fees and charges are due in advance.
- GST is charged where applicable.
- Late payment of fees attracts a surcharge of \$20 per week calculated from the due date.
- The Contingency Bond (Room Holding Deposit \$200AUD plus the Residency Acceptance Bond \$400AUD = \$600AUD), is payable as a security deposit for maintenance of College property and compliance with the Conditions of Admission and the Rules.
- The Contingency Bond will be returned at the end of the contract. Note that any money owing will be deducted before payment.
